## Program Overview

# Be Venture-Capital Ready

The last iteration of this program was widely successful, but allowed for broader, less focused service delivery. Learning from our previous program, the **NEW Venture-Capital Ready** has been streamlined to better serve and guide our targeted women entrepreneurs. Designed for market-tested, women-led businesses, it aims to ensure entrepreneurs are prepared and confident for the investment process. This program is free for all.

## Program Process

### 1 Assessment

- Complete our self-assessment. If you're eligible, you'll be directed towards the next step.
- If you aren't eligible, that's okay, we'll direct you to alternative resources that could help you take the next steps in your business.

### 2. Program Learning

- Complete our 8-module, 10-week Venture-Capital Ready program.
- Access up to 2 hours of topic-specific coaching.
- Each week, attend our open forum Q&A for extra clarity or guidance.
- Expect to invest between **5-10** hours per week between sessions, coaching opportunities, and learning resources.

### 3. Pitch Practice

- Develop your pitch deck, then present your pitch to your peer group of other female founders to give and receive feedback.

### 4. Pitch Party

- Finally, join a pitch party to deliver a confident, clear, investor-grade pitch and have the opportunity to engage investors with clarity and purpose.

### 5. Open for Investment

- For everyone who pitches during the Pitch party, complete your One Sheet in preparation for investor review and potential reach out!
